

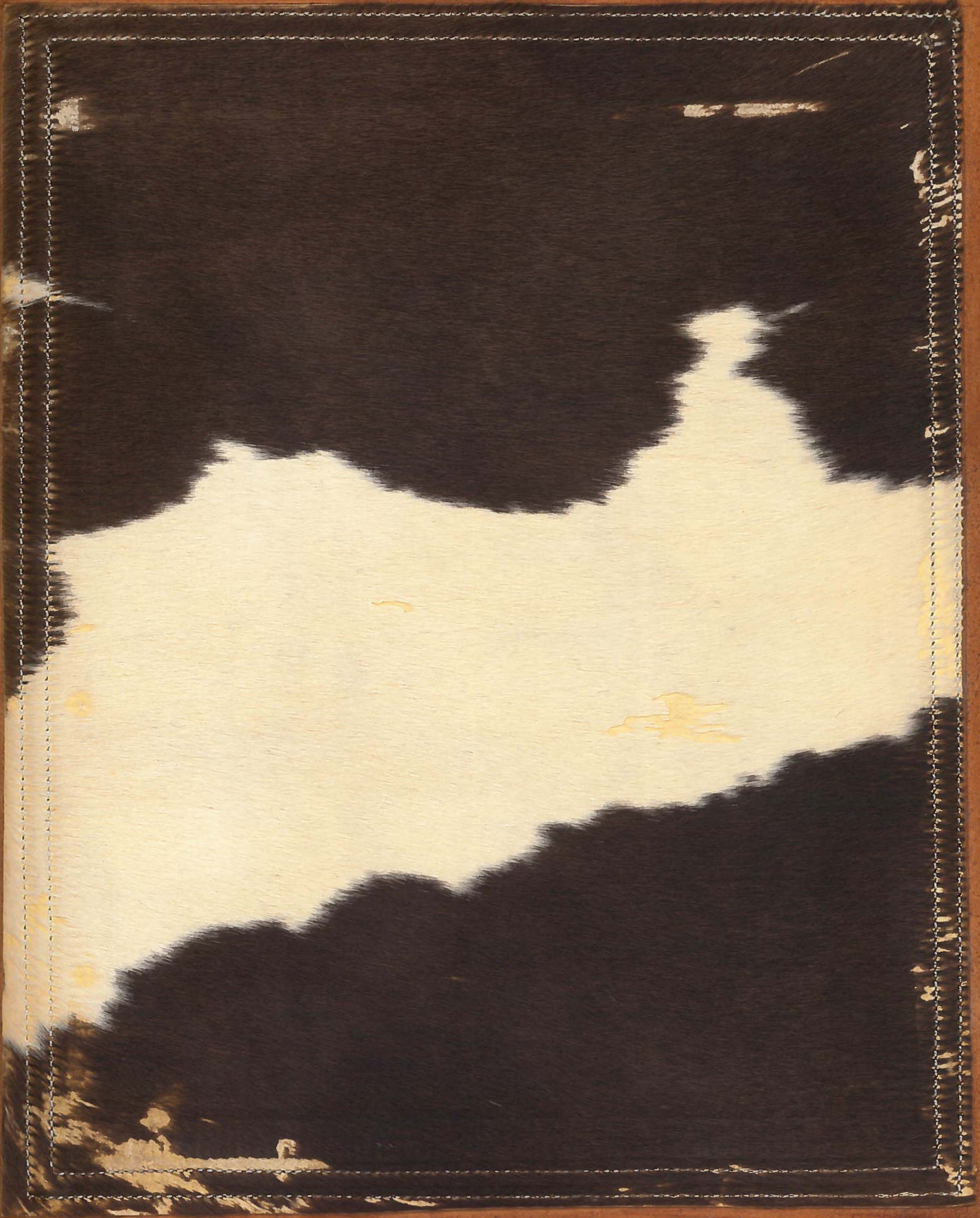
LE COMITE INTERNATIONAL OLYMPIQUE

Gentlemen: It gives me genuine pleasure, as Mayor of the City of San Francisco to extend a cordial invitation to Le Comite International Olympique to conduct the Olympic Games in San Francisco and the great cities of its environs, at the earliest practicable time. ♦ This invitation comes to you backed by official resolution of the Board of Supervisors of San Francisco. It has the wholehearted support of our people, and you may rest assured that no effort will be spared to make suitable provision for the service, the comfort, and the performance of the athletes. ♦ The facilities of San Francisco and her environs are so varied and offer so many choices for each event of the Olympic Games, that to catalog them would unduly impose upon the attention of the Committee at this stage. We shall subsequently provide the Committee with a complete, detailed description of the facilities here available for the Olympiad. ♦ The Committee will be happy, on behalf of the comfort and performance of its athletes, to remember that the climate of San Francisco has been pronounced by the American Society of Meteorologists to provide temperatures and humidities which never at any time rise above or fall below those required by the human body for its maximum efficiency. ♦ I express the hope of all our people that the City of San Francisco, birthplace of the United Nations, may again witness an expression of international friendship through the performance here of the Olympic Games.
